Safeguarding Hubs

We were pleased to share preliminary information about the new 'Safeguarding Hub' with those who attended the recent PSO & Lead Recruiter briefing; thank you for the feedback that you shared.

The Safeguarding Hub is now live in our diocese and will initially be made available to parishes who are working at Level 3 of the Parish Dashboard. As with the Parish Dashboard, there will be no charge to parishes for use of the Safeguarding Hub.

<u>This link</u> will take you to the two information videos that we played during the PSO/ Lead Recruiter briefing, which provide an overview of the Safeguarding Hub and an overview of Stage 1.

A brochure is also available to help inform you and your PCC; these resources have been added to the website safeguarding pages in <u>the Parish Safeguarding Resources</u>.

The Safeguarding Hub has been created by Clearly Simpler, creators of the Parish Dashboard. The hub works alongside the Parish Dashboard to support parishes with safer recruitment and people management. We have identified a small number of volunteer parishes who will trial it initially and will provide feedback to us which will support us with resolving any teething issues. It is expected that the Safeguarding hub will be accessed and administered by the Lead recruiter and/or the PSO, whichever is most appropriate for your parish. We understand that others can be invited (by you) to see certain parts of the Hub, such as stats on sections completed, but we are seeking clarification to ensure there are no implications for GDPR and existing permissions. One of the biggest advantages of the Hub is that personal data on your volunteers will be held securely and not on your personal devices. It is a cloud-based storage system which is secure.

The Safeguarding Hubs will be Iaunched in four

stages:

Stage 1 - DBS and training records
Stage 2 - Role descriptions and person specifications
Stage 3 - Safer recruitment
Stage 4 - People management

We hope you will see the potential gains of this addition to our support measures. If you have any queries, please do get in touch.

Parish Dashboards

It has been great to hear from several PSOs since the briefing who have requested support with accessing the dashboard. These PSOs are now in contact with our dashboard ambassador, Pete Edwards who is supporting each PSO individually with access to the dashboard and using it to its full potential.

Parish Dashboard is an online system that gives assurance to parishes that they are complying with statutory requirements and Church of England policies, or else it explains what actions need to be taken. It also enables dioceses and the national church an oversee compliance, and to focus their support on the areas of greatest need. Its primary aim is to make life simpler of Parish Safeguarding Officers. It shows an overview of their parish at a glance, and this can be shared with their incumbent, churchwardens or other authorised users.

"The dashboard has been a fantastic tool to enable us to be abreast of the requirements for safeguarding and prioritise actions for our parish with new items appearing in term as you progress. The clear formatting of the dashboard means that it is easy to identify action and understand what needs to be done to remedy these." - Naomi Mackness, PSO of St Mary's Church, Radcliffe on Trent

Our aim for 2023 is to significantly increase the uptake and ongoing use of the dashboard. Parishes who are not currently using the dashboard will be contacted by Stephanie Spencer, Safeguarding Case Worker, in the near future to offer support.

As discussed at the last briefing, it is a mandatory requirement for all PCC members to complete the Domestic Abuse Awareness course. Please ensure this information is relayed to your PCC members, directing them to the training page of the Diocese website.

PSO/DBS Lead Recruiter/DSAP Members Skills Audit

Thank you to everyone who completed the online skills audit last summer – we gained some very useful quantitative and qualitative data which has been used to inform four key areas we plan to develop in 2023

- The first priority is to further promote and support the use of the dashboard, by signposting to Pete Edwards, Parish Dashboard Ambassador. We plan to add information to the Diocese website about the support Pete is able to offer and an email will also be sent to all dashboard users with Pete's contact information. Two additional PSO's have also offered to support Pete with helping others to access the dashboard. The DST caseworker then aims to contact each PSO individually who is not currently accessing the dashboard users.
- The second priority is to develop a mentoring system for PSO's and DBS Lead/Deputy Lead Recruiters. The DST will identify PSO's who have been in post for one year or more who are willing to become a mentor, with the aim to have a minimum of 3 mentors in each archdeaconry. A mentor role description will be designed. The DST will then reach out to individuals who are new in post or struggling with aspects of the post to offer this mentoring support. The DST are proposing that mentoring relationships will last for one year and then be reviewed.

- The third priority is to develop a PSO/DBS Lead/Deputy Lead Recruiter induction handbook, to include all of the resources required to fulfil the role, along with additional information including a glossary of terms, a 'who's who' poster of the DST and an FAQ's sheet.
- The final priority is to develop relationships between the DST, DSAP and PSO's and DBS Lead/Deputy Lead Recruiters. The DST aim to do this by organising face to face events for networking and socialising, the first event taking place in summer 2023.

The skills audit also highlighted how blessed we are as a Diocese to have such a wide breadth of skills and expertise amongst our PSO's, DBS Recruiters and DSAP Members – we are so grateful for your commitment to your roles and for your dedication to making our churches safer worshipping communities.

PSO/DBS Recruiter Face to Face event

We are really keen to build relationships between the DST, DSAP and PSO's/DBS Recruiters across the diocese and to give something back to you for the dedication you show to the part you play in promoting safeguarding across our churches.
