**NOTE – Substitute Ministers for Weddings and Funerals**– This **ONLY** applies to **Retired Clergy with Permission to Officiate** and **licenced Self-Supporting Ministers (except SSM curates in training)** and for funerals only, **Readers who have had funeral training.**

**CASUAL DUTY FEE £40** – This **ONLY** applies to **Retired Clergy with Permission to Officiate** for a Sunday or weekday service when not in the parish in which they normally worship. In addition, casual duty fees are payable for **Retired Clergy with Permission to Officiate** in the parish where they normally worship if this is during vacancies, holiday cover, sabbaticals, and periods when the incumbent/Priest in charge has long-term sickness – i.e. after a month).

**Self-Supporting Ministers** (except SSM curates in training and SSM house for duty posts) are eligible for a casual service fee on the same basis as Retired Clergy with Permission to Officiate (as outlined above).
